  - Product Lens Program Report

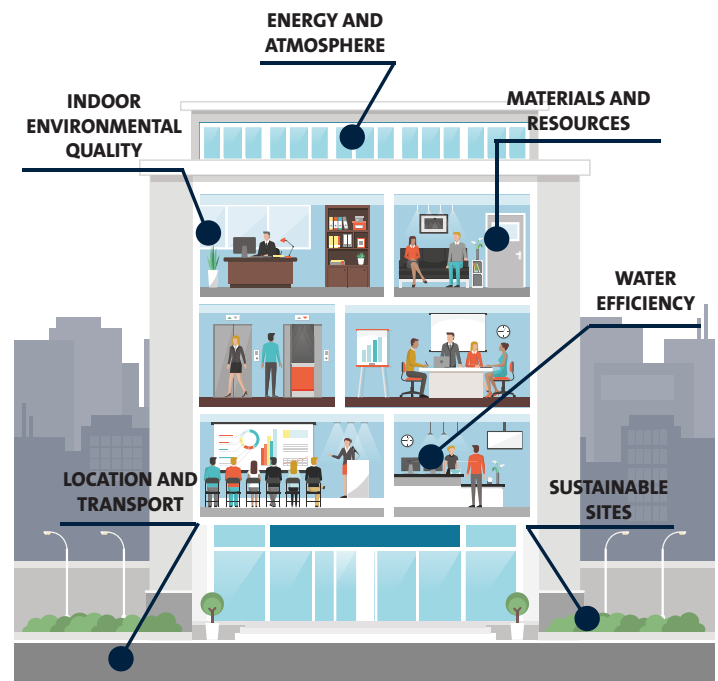
